



Junior League of Tulsa | 2020-21 Financial Package

Membership Dues

- Active and Provisional Dues: \$200*
- Non-Resident Active Dues: \$100

Sustaining Dues

- Under 65 years of age: \$100 Sustaining Dues
- Over 65 years of age: \$75 Sustaining Dues
- Over 80 years of age: \$0 Sustaining Dues

Membership dues and payment plan sign up deadline: **May 31, 2020*

Membership Fees

- Provisional Course Fee (one-time fee): \$100

Fundraiser Requirements for all Active and Provisional Members is \$100** to be paid as follows:

\$100 in Mentorship Luncheon Tickets, Gem Gala Tickets (Gala or After Party), cookbooks, or any other Board approved fundraiser. The fundraising obligation must be fulfilled no later than **April 30, 2021**. Failure to fulfill the fundraiser requirement prior to the stated deadline will result in a penalty of double the requirement, up to a \$200 penalty.

Work Shifts for all Provisionals and Active Members Years 1-2

One 2-hour work shift at Mentorship Luncheon, Gem Gala, Headquarters, or any other Board approved work shift.

- *Actives (Years 3+), Sustainers, Finance Committee members, and members of a JLT fundraiser committee - No fundraising work shift requirement*
- *Failure to complete the work shift requirement will result in a \$100 penalty.*

Each member will select her preferred work shift during Placement Scramble, and they will be filled based on first-come, first-serve basis.

President's Society Sponsorship

As a participant in President's Society, Active or Provisional membership dues and fundraiser requirements are fulfilled. Members can pay the entire amount at once, or payment plans up to 12 months are available. The payment plan sign up deadline is **May 31, 2020**. The following are the President's Society sponsorship levels and benefits summary:

- President's Society Jewels - \$1,200
 - *2020-21 Membership Dues, Gem Gala Sponsor (includes 2 Gem Gala event tickets and recognition in event materials), Mentorship Luncheon Sponsor (includes 2 event tickets and recognition in event materials), 2 Trivia Night event tickets, \$100 donation to the JLT Endowment Fund, and \$100 donation to the JLT Building Fund*
- President's Society Leaders - \$800
 - *2020-21 Membership Dues, 1 Gem Gala event ticket, 1 Mentorship Luncheon event ticket, 1 Trivia Night event ticket, \$75 donation to the JLT Endowment Fund, and \$75 donation to the JLT Building Fund*
- President's Society Trailblazers - \$400
 - *2020-21 Membership Dues, 1 Mentorship Luncheon event ticket, 1 Gem Gala After Party event ticket, \$30 donation to the JLT Endowment Fund, and \$30 donation to the JLT Building Fund*

Please note the President's Society sponsorship benefits are subject to change at the discretion of the Junior League of Tulsa pending event scheduling and confirmation. Should any modifications to this benefits package be required, both the dues and fundraiser requirements of President's Society participants will be satisfied by the modified benefits. President's Society benefits are not transferable between fundraisers.

Fundraiser Sponsorships

JLT fundraiser sponsorships from an individual member or a member-owned business will satisfy the member's fundraiser requirement of \$100.

Buy Out Option

All Provisional and Active members have the option to buy out their financial obligation. Members will receive a tax deduction for the buyout amount; however, no tickets will be provided in exchange for this payment. This buy out can be paid in one payment or via payment plan.
